Supervisor: Mrs. Gale reported that Blake Evans has sent out notification that the NGE and No Contact Letters would be mailed out for 2023 List maintenance. The NGE letters (338) will be mailed by the State the week of July 24th and No-Contact letters (165) sent to us for this office to mail out by July 31. NGE letters are for former voters who have not participated in any General Election within the last two even-years (2020 and 2022). The No-Contact letters are sent to former voters who have not had contact

with their registrar in the last five calendar years. Each person has 30 days to respond or be removed from the voter rolls.

This office has been working on redistricting for the North and South Wards for the city and are waiting on approval from the State on the data she turned in. After that is completed the affected city residents will get new registration cards. Qualifications for the next Election will be done by the city (Mayor and two City Councilmen – one for each ward).

Mrs. Gale also reported that Effingham County will host the next Region 11 Quarterly meeting and they need a head count by the end of this week for lunch. Please contact her before Friday. This meeting is on July 25th at 12 pm.
